I, AADHAR SEWA SAMITI Run by All aadhar operators, President Shri Sheshnarayan Sahu, Office Village :- Barna, , District:-Dhamtari, operator of Outsourced/VLE model for Aadhar Centre as Lok Sewa Kendra at Govt. Permiss and registered with agency name Chhattisgarh Infotech Promotion Society(CHIPS), within State of Chhattisgarh, requesting you not to change the set-up of Aadhar enrolment and update of enrolled entries of citizens to in house model from Outsourced/VLE model, in your office Memorandum vide F.No.HQ-16024/4/2020-EU-I-HQ-Part(1), dated 14/10/2022 for shifting of the Registrar/EA working under outsourced/VLE shall be shifted to in-house model by 31st March 2023 and further directing the Registrar Mapped with RO with following condition:-

- No New Operator on boarding and new activation if client shall be done if it is not following the in-house model.
- The existing operators & Clients not working under in-house model shall be identified registrar wise. Further 20% of such operators and clients shall be deboarded every month (20% each on 30th November, 31st December 2022, 31st January, 28th February and 31st March 2023).

And the request has been made to ROs are requested to pursue the matter with registrars/EAs functioning under their jurisdiction for shifting from Outsourced/VLE model to in House Model so that all Aadhaar center are working only under in-house model w.e.f 01.04.2023.

That, the Date of Shifting has been extended to 07.01.2024 due to Bharat Sankalp Yatra.

It is the request of me Not to Shift the Registrar/EA working under outsourced/ VLE shall be shifted to in-house model for various reasonable reasons such as, I am not been alleged even for an single time for mis-conduct, I am been working under the premises of Govt of State, I am been completely dependent on the Aadhar centre for whole livelihood and the Charge rate should be deposited to government account for service done and no personnel of government be appoint as operator and the previous existing model/Outsourced/VLE model be continued and the charges for services are the only source of Income for survival of livelihood of me and my family.

It is Humbly requesting to you that, Outsourced/VLE model be continued and the existing Outsourced/VLE model not be shifted to in-house model.
